



FANANO SAXOPHONE INTERNATIONAL COMPETITION

1st Edition

Art. 1 – The association "Amici del Progetto Musica – E.T.S", under the artistic direction of Quartetto Saxofollia, organizes the 1st edition of the "Fanano Saxophone International Competition."

The competition aims to highlight the saxophone and its repertoire, creating opportunities for young musicians to connect and exchange experiences. It also seeks to encourage and support the development of emerging talents in the saxophone world.

Art. 2 – Participation is open to saxophonists of all nationalities and is subject to the payment of a registration fee. The fee must be transferred to the following bank account: IBAN: IT19U 05387 12996 000002175262

Account holder: Associazione "Amici del Progetto Musica - E.T.S"

Payment reference: "Registration fee for the Fanano Saxophone International Competition," specifying the participation category.

Art. 3 – Registration Fees

Fees vary based on the competition category, each with specific age limits.

For the Saxophone Quartet category, the average age of the members must not exceed 30.

Each member registered in the "Saxophone Quartet" category may also register in only one soloist category.

- Senior Category No age limit: € 50.00
- Junior Category (Born in or before 2006): € 40.00
- Young Category (Born in or before 2009): € 30.00
- Saxophone Quartet Category: € 100.00 (€ 25.00 per participant)

Note: <u>Participation in the competition is FREE for those registered in the Fanano Saxophone Week 2025 course.</u>

Art. 4 – Categories and Repertoire

Participants may choose music from the original repertoire for:

- Saxophone and piano
- Saxophone and orchestra
- Solo saxophone
- Saxophone and live electronics

Transcriptions of works from other instruments are also permitted.

Performance time limits by category:

- Senior Max 20 minutes
- Junior Max 15 minutes
- Young Max 10 minutes
- Saxophone Quartet Max 20 minutes

Art. 5 – Preliminary Round (Video Selection)

The first selection will be made by *Quartetto Saxofollia*, based on video submissions by the candidates:

- Senior Max 10 minutes
- Junior Max 7 minutes
- Young Max 5 minutes
- Saxophone Quartet Max 10 minutes

Video requirements:

- Must be recorded from a front or side view
- Must be unedited, with no cuts or splicing
- Upload to YouTube with visibility set to "Unlisted"

Submit via email:

- Completed registration form
- Proof of payment (or proof of enrollment in Fanano Saxophone Week)
- A valid ID proving age
- YouTube video link

Deadline: Submissions must be received by 6:00 PM on June 23, 2025.

Selection results will be announced by July 7, 2025.

Art. 6 – Final Round

Selected participants must attend the final round in person on Sunday, July 20 at 10:00 AM at the Church of St. Joseph in Fanano (MO).

Performances will follow alphabetical order, starting from a letter drawn the same morning by the artistic committee.

Exceptions to these rules may be granted in case of documented reasons, provided they are communicated in the registration form and approved by the organizers.

Art. 7 – Jury

The jury's decisions are final and not subject to appeal. Scores will range from 1 to 100. Jury members:

- Fabrizio Benevelli Member of Saxofollia, Saxophone Professor at Conservatory "F. A. Bonporti" (Riva del Garda)

Art. 8 - Accompanist

The organization provides an official piano accompanist for the final round: M° Marianna Tongiorgi. This service is offered at no additional cost.

Art. 9 – Awards Concert

The awards concert will take place on Thursday, July 24 at 9:15 PM.

This event is part of the concert series for the "Fanano Saxophone Week - 10th Edition."

The concert program will feature first-place winners from each category.

The concert will take place in November 2025, with a gross fee of €400.00.

Accompanist: M° Marianna Tongiorgi (paid by the organization).

** The first-place Saxophone Quartet will receive the Zeno "Benes" Carretta Scholarship (€400.00), to be collected in Parma during a dedicated event.

The quartet must perform a 20–30 minute program of their choice from the saxophone repertoire (solo, duo, trio, or quartet).

- Art. 11 The Artistic Direction reserves the right to make changes to this regulation if necessary. In such cases, all registered participants will be promptly notified, and any paid fees will be refunded.
- **Art. 12** The *Amici del Progetto Musica E.T.S.* Association declines any civil or moral responsibility toward the participants.

Each participant is solely responsible for their physical and moral safety during their stay and related travel.

The Association is not liable for any damage—material or immaterial—caused by participants to people or property.

Art. 13 – Personal Data and Media Use

In compliance with EU Regulation 2016/679 (GDPR) and Italian Legislative Decree 196/2003, personal and audiovisual data submitted by candidates will be used exclusively for purposes related to the organization and management of the competition.

Videos submitted for selection will be used solely for artistic evaluation by the jury and will not be published or shared without prior written consent.

For **minors**, participation requires written authorization from a parent or legal guardian, explicitly consenting to data processing and video use as described.

Consent is mandatory for participation; without it, registration cannot be accepted.

Art. 14 – Participation in the competition implies **full and unconditional acceptance** of these regulations.
